The Dependency and Probate Court Processes— Understanding what's happening when children are in court.

This training is geared towards family partners, resource family advocates and clinicians working with children, youth and families involved with CPS in Alameda County.

Workshop Description

This training is designed to explain the basic framework of two court processes involving the custody of children—the juvenile dependency process and the probate guardianship process. You will learn who initiates each court process, what rights and responsibilities different individuals have within each process, the series of hearings that occur in each court, and what determinations are being made at each hearing. The two systems will be compared and contrasted throughout. You will hear from an attorney who has represented children in both systems about how clinicians and attorneys can work together to support their mutual clients throughout either process and what is at stake in terms of outcomes for children and families. The role of the attorney will be explained as well as the roles of other service providers and individuals within both court systems.

The Trainer

Kristin Mateer is a co-founder of East Bay Children's Law Offices, founded in 2009, and its Executive Director since April of 2018. She is a Child Welfare Law Specialist who began representing both children and parents in the juvenile dependency system in 1998 with the Alameda County Public Defender's Office. After the founding of EBCLO which was created when the Public Defender closed its dependency office, she became a Managing Attorney and supervised dozens of lawyers and continued her own practice representing children. In 2011, she created EBCLO's Probate Guardianship for Children program and began representing children in probate guardianship proceedings. She continues to represent a handful of children in each court system. Prior to going to law school, Kristin was a volunteer Court Appointed Special Advocate through San Francisco CASA. Kristin then served on the Advisory Board of Alameda County CASA from 2009-2018 serving as its Chair from 2011-2018. She has a BA in Political Science from UCLA and a JD from UC Hastings College of the Law. She is a member of the National Association of Counsel for Children. And she's the mom of two amazing daughters!
