**POSITION SUMMARY:** The Substance Abuse Specialist is responsible for counseling and supporting parents who receive CalWORKs Welfare to Work benefits with alcohol, tobacco, drug, or other substance use disorders in order to help remove barriers to self-sufficiency. The SA Specialist is an integral member of Family Paths CalWORKs program's treatment team, along with Mental Health, Employment and Peer Specialists.

This requires the demonstration and commitment to the agency's mission, vision, and values, including a strong commitment to creating and sustaining a culturally diverse workforce.

#### **ESSENTIAL DUTIES & RESPONSIBILITIES:**

- Provide substance abuse counseling to clients and their families individually and in group sessions.
- Refers client to other support services as needed.
- Monitors progress and adapts treatment as needed.
- Participates in collaborative treatment teams meetings.
- Participates in related trainings and workshops.
- Travels throughout Oakland as needed to meet the needs of the clients.
- Maintains an appropriate caseload and meets program billing goals as determined by Program Manager.

- Associate's Degree (AA) or Bachelor's Degree (BA) preferred but not required dependent on experience.
- 3 years' experience in the substance abuse treatment field.

- Computer skills required: Microsoft Office Suite; ability to use electronic health record system.
- Ability to model recovery core principles and values.
- Experience working with people with complex needs who are exhibiting mental health issues.
- Knowledge of community resources, specifically related to substance abuse treatment.
- Good organizational skills and ability to handle multiple priorities.
- Knowledge of trauma's impact on families.
- Ability to implement strategies that incorporate the family's cultural values and strengths.
- Ability to exercise good judgment and work independently, legally and ethically.
- Ability to communicate effectively and respectfully, both verbally and in writing.
- Ability to work as part of a team and address differences and conflicts in a proactive manner.
